CODE OF ETHICS

3. It is the obligation of those more experienced in the breed to give advice and assistance to less experienced fanciers in a spirit of kindness and courtesy.
4. Members shall at all times maintain a high standard of health and care for their Clumbers. Members will comply with all Canadian Kennel Club rules and regulations where they apply.
5. Members will help to educate the public on the Standard and the proper care of the Clumber Spaniel.
6. No member shall sell or produce for sale, or consign puppies or adults to any auction, dealer, laboratory, pet shop, or as give away prizes.
